
Consequent upon approval from Govt. for conduct of online exams of summer semester exams and considering requests from different Institutions, Vidyarthi portal shall be reopened for uploading of data of Exams Registration and Form fill up of Regular and Ex-Regular students of 2nd/4th/6th/8th(PT) semester Summer 2021 Exams of Diploma and PDIS Courses only on 05/08/2021 from 9 AM to 4 PM.

No request for further extension of date and time for uploading of the above data on whatsoever ground shall be entertained.

In case of any discrepancy in data uploading of form fill up of above semester, institution may send mail to cont.sctevtodisha2016@gmail.com upto 12.30 PM of 5/8/2021, beyond which such mails shall not be entertained.


Demand Notes for payment of Exams fees for the above students shall be generated in the portal for online payment on 06/08/2021 FN. The last date for making online payment against such Demand Note is 07/08/2021. Data of students shall be extracted from database on 06/08/2021 and shall be processed for online exams.

In case payment of Demand Note is not made by the institution in due time, the students concerned shall not be allowed to appear the exams.

It is hereby informed that, Govt. in SD&TE Department vide their letter No. 3404/SDTE dt. 30.7.2021 have approved for conduct of 2nd/4th/6th/8th(PT) semester 2021 Summer Exams of Diploma and PDIS course in online mode. The 1st Sem Diploma examination will be conducted on Physical mode after reopening of Institution


1. Regular and Ex-Regular Students, who have filled up form for the above semester Summer Exams 2021 in Vidyarthi portal as per procedure, are eligible to appear in the respective Summer Semester Examination 2021.
2. There shall be online exams for Theory subjects only. There shall be Physical Exams for Practical subjects as usual.
3. To appear online Theory Exams, the students already filled up forms as stated above are required to make additional registration in online exams portal for appearing above online exams.
4. Students who have not filled up forms for the above semester Exams in Vidyarthi portal and not registered in the online Exams portal for respective semester exams, shall not be eligible for online Theory Exams.
5. The above 2nd/4th/6th/8th(PT) semester 2021 Summer Exams (Theory subjects) shall be held one after the other in the order of 6th/8th, 4th, 2nd semester. The tentative date of Theory Exams of 6th semester shall be from 23/8/2021 to 31/8/2021. The detailed programme of 6th semester and other semesters shall be notified in due course.
6. The students shall be allowed to appear in the online exams from home using Laptop/Desk top computer/Android based mobile phone through internet connection on their own arrangement.
7. Students having genuine difficulty in arranging the above computing device and/or internet connectivity of appropriate speed/bandwidth can appear the exams from their own Institutions.
8. Every Polytechnic shall be treated as Exams centre and are required to provide sufficient computing infrastructure and reliable internet connectivity of appropriate speed and bandwidth to their own students willing to avail such facility.
9. It is being planned to conduct such examination through remote Proctored mode. For this purpose, stable internet connection with minimum 512 Kbps speed internet connection is a prerequisite for appearing in the exams from a location.
10. It is the responsibility of the student concerned to arrange reliable and stable internet connectivity of minimum 512 Kbps speed through out the entire sitting of exams. SCTE&VT shall not be held responsible for failure/instability of internet connectivity during the exams.
11. The pattern of Exams shall be MCQ type and duration of each sitting of exams for a Theory subject shall be of 2 hours.
12. The Practical Examination shall be conducted in physical mode as usual. There is no need of separate registration by the students in online exam portal for Practical Exams.



13. The registration for online Theory exams of eligible students as stated above, exercise of choice of Exams centre shall be done in the online exams web portal in SCTE&VT website in due course. The students so registered in online exam portal of SCTE&VT have to be approved by concerned Institute particularly with respect to the choice of Exams centre so as to be allowed to appear Theory exams in online mode from the Institution centre/ home.


